★ **Service Request and Scheduling: Online or by phone**

- Additional rental days beyond the agreed end date will be charged at a rate of \$25 per day or by the week, subject to availability, until the roll-off is picked up.

★ **Cancellation Policy**

- 72 Hour cancellations will receive a full refund
- Cancellations made within 24 hours will incur a \$100 cancellation fee
- Same-day cancellations will be subject to a \$200 cancellation fee

★ **Additional Charges**

- Customers are responsible for:
 - The total weight of the contents in their dumpster(s) Dump Fee
 - Schedule the removal of their dumpster(s) when needed
 - Ensure that their dumpster(s) are not overloaded
 - Inspect the dumpster upon delivery for any existing damage
 - Exceeding Weight Allowance Fees
 - Third-party services or machines for compacting trash in the dumpster are not permitted
 - Loading debris above the top walls of the dumpster will result in a \$150 FEE
 - Deep cleaning on dumpster will result in an additional fee paid to a third party company
 - NO PICK UP FEE OF \$250 WILL APPLY IF WE CANNOT ACCESS THE DUMPSTER ON SCHEDULED PICK UP DAY
 - Move fee or Relocation fee \$150
 - NONE OF THE FOLLOWING ARE PERMITTED IN THE DUMPSTER
 - TIRES
 - OIL
 - PAINT
 - CONCRETE/BRICK

The customer retains title and liability for any Prohibited Waste at all times. DUMP QUEEN reserves the right to inspect, analyze, and/or test any waste delivered by the customer to ensure compliance with these guidelines. The customer acknowledges that DUMP QUEEN will not be held liable for any damage to driving surfaces resulting from the service provided by our trucks in the agreed-upon areas and their surroundings. Furthermore, the customer acknowledges that they are not permitted to move roll-off containers using personal or third-party equipment.
